1.0 INTRODUCTION

1.1 GENERAL

The Department of Indian Affairs and Northern Development (DIAND) commissioned EBA Engineering Consultants Ltd. (EBA) to review and summarize the granular resources studies undertaken by EBA in the Northwest Territories. The main objective of this project was to identify and provide the granular resource reports completed by EBA and its ancestors or affiliates in the Northwest Territories with emphasis on their availability for publication to a web-based northern granular resource data base.

This project was completed under the authorization of the DIAND Contract Requisition Number: A7133-04-0030.

1.2 PROJECT DETAILS

Granular resources have been identified and explored by different private and public agencies, in different parts of the Northwest Territories, in the past. Most of the information on granular resources was collected in connection with the construction of a proposed gas pipeline in Mackenzie Valley, highway projects, and development of mining and community infrastructure.

Information on the availability of granular resources is essential for effective planning and management of the future community needs and development of public and private infrastructure. To make this information available and easily accessible to the planners and managers, Arctic Institute of North America (AINA) has developed a web-based Northern Granular Resource Database. This database contains abstracts and/or reports of granular resources projects undertaken in Canada's three northern territories and adjacent waters. The current project is an effort to update this database by incorporating newer information, and reviewing the completeness of already available online reports, completed by EBA in the Northwest Territories.

EBA has previously prepared a preliminary report identifying granular resources studies conducted by EBA in the Northwest Territories (EBA File: 1700160, dated April 12, 2006). A list of these reports was prepared and submitted to DIAND, as part of that report.

1.3 SCOPE OF WORK

EBA's understanding of the required scope of work for this component of the project, consistent with Tasks 4 to 9, as outlined in the draft contract, is as follows:

- Determine the current or potential availability of granular resources reports, identified by EBA in the preliminary report;

- Check the completeness and quality of reports which are already available online on Northern Granular Resource Database, noting dates at which online reports were reviewed and providing itemized lists of missing pages, figures, or any other problems noted;
- Obtain permission to release those reports that were not completed for Indian and Northern Affairs Canada (INAC), DIAND, and Public Works Canada (PWC) and that are not available online;
- Identify any areas for which there are significant gaps in information, particularly related to Mackenzie Gas Pipeline and associated infrastructure;
- Provide recommendations to fill the data gaps and make the existing information more accessible to planners/managers; and
- Prepare a report documenting the work completed and presenting the resulting recommendations.

2.0 METHODOLOGY

2.1 REVIEW OF EBA'S GRANULAR RESOURCE PROJECTS

A review of EBA files was conducted to identify the granular resource reports completed by EBA in the Northwest Territories. EBA offices at other locations were also consulted to complete the list as much as possible. A list of these reports was prepared, and compared with records shown on AINA's website. This list was faxed to DIAND on March 7, 2005, for review.

The comments from DIAND were received on March 11, 2006. The list was updated in light of those comments, by indicating which reports have been indexed in Northern Granular Resource Bibliography (NGRB) or Arctic Science and Technology Information System (ASTIS). The ASTIS record numbers and libraries having copies of these reports were also indicated in the list. A preliminary letter report with a list of EBA reports was submitted to DIAND in April 2005. This report is presented in Appendix A.

The list of EBA reports provided in the preliminary report is subdivided and reproduced as Tables 1, 2, and 3.

Table 1 presents EBA granular resource studies that are in the public domain and are available on NGRB. A review of these reports was required in order to check their quality and completeness.

Table 2 presents granular resource reports that are not available online. These projects were prepared for INAC/DIAND; therefore, permission to release these reports to the public domain is not required. As these reports are not available online, their quality and completeness could not be reviewed.

Table 3 presents reports that were prepared for either private agencies or the territorial government. Permission to release these reports to the public domain was required.

2.2 REVIEW OF QUALITY AND COMPLETENESS OF ONLINE REPORTS

A review of the online reports was conducted to check their completeness and quality. An itemized list of the deficiencies noted in the online reports is presented in Table 4. The reports with deficiencies were corrected. The corrected copies were provided to DIAND. Digital copies of these reports will be provided as part of this project. Digital copies of corrected reports are presented in Appendix B.

The reports shown in Table 2 could not be reviewed because these were not available online during the course of this project. EBA can review these reports if requested and once these reports are available online.

2.3 REPORT RELEASES

To release reports, listed in Table 3, to the public domain, letters were sent to representatives of Fortune Minerals Ltd., Northwest Territories Power Corporation, BHP Billiton Diamonds Inc. (BHP), Government of the Northwest Territories (GNWT), Department of Transportation (DOT), and Imperial Oil Ltd. Copies of reports released, and corresponding release letters, were provided to DIAND. BHP declined to release two reports that EBA has prepared for them. Imperial Oil Ltd., also declined to release one of the two reports for which release was requested. Table 5 presents reports that were released to the public domain during this project. Release letters are presented in Appendix C. Digital copies of the released reports are presented in Appendix D.

EBA has recently conducted granular resource investigations in the Mackenzie Valley in connection with the Mackenzie Gas Project (reports on Serial Nos. 1, 2, 4, and 5 of Table 5). In order to release these reports to the public domain, DIAND was requested to contact ColtKBR directly. EBA can provide digital copies of these reports once these reports are released to the public domain.

EBA was not able to locate reports on Serial Nos. 11, 15, and 16 of Table 5. Therefore, letters to request release of these reports were not sent. The report on Serial No. 12 was completed for Dome Petroleum Ltd. and Canadian Marine Drilling Ltd. These companies no longer exist; therefore a request for release could not be sent.

3.0 INFORMATION GAPS AND RECOMMENDATIONS

A significant body of information on granular resources was collected from 2003 to 2005, in the Mackenzie Valley, in connection with the proposed gas pipeline. These reports are not available online. These and other reports identified in this project should be included in the database. EBA can provide digital copies of these reports once released.

Most of the granular resource reports are very old, i.e. prior to 1990. Information on the current availability of these granular resources is not available. Up to date information on each granular deposit i.e. current pit use and availability of granular material from these sources, should be collected and posted on the website. This will assist planners and managers in assessing the availability of granular resources for future needs.

The granular resources inventory should be maintained by updating the database annually with newly acquired information. Once complete the database will provide a reliable source of granular resources in the Northwest Territories.

A disclaimer should appear before downloading the online reports. EBA has drafted a standard disclaimer that may be modified if considered necessary by DIAND. The disclaimer should be as follows:

"All documents appearing on the NGRB are in the public domain and may be reproduced or copied without permission. In any subsequent use of these documents, the source should be cited and given appropriate acknowledgement. The documents may not be used to create publications or databases without prior permission from ASTIS.

Every effort is made to provide accurate and complete documents; however, there is no guarantee that these documents are error free. Also there is no guarantee on the completeness of these documents."

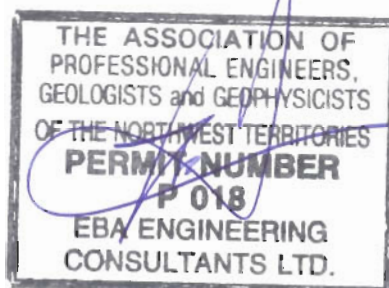

1.0 INTRODUCTION

This report presents the results of a preliminary review of granular resource studies undertaken by EBA Engineering Consultants Ltd. (EBA) in the Northwest Territories (NWT). This report is the first component of a larger study. The main objective of this component was to identify and summarize the granular resources related work undertaken by EBA and its ancestors or affiliates in the NWT.

This project was completed under the authorization of Department of Indian Affairs and Northern Development (DIAND) Contract Requisition Number: A7133-04-0030.

2.0 SCOPE OF WORK

EBA's understanding of the required scope of work for this component of the project, consistent with Tasks 1, 2, and 3, as outlined in the draft contract, is as follows:

- Identify and prepare a list of all granular resource studies undertaken by EBA in the NWT;
- Indicate the sponsoring agency i.e. government department (Federal, Provincial, or Territorial) or private;
- Compare this list with records currently shown on the Northern Granular Resources Bibliography (NGRB) or Arctic Science and Technology Information System

- (ASTIS), and identify reports that have been indexed and/or accessible online in PDF; and
- Prepare a preliminary report documenting the findings from this review.

3.0 REVIEW METHODOLOGY

A review of EBA files was conducted for identification and preparation of a list of all granular resource projects completed by EBA in NWT. EBA's different offices involved in borrow investigations in the past were also approached to complete the list as much as possible. As these projects were completed for different private and public agencies, sponsorship of the studies was also indicated in the list.

This list was then compared with records currently shown on NGRB and ASTIS to find which EBA reports are accessible online in PDF. It should be noted that a quick search on NGRB for EBA's granular studies in NWT (geographic region = G0812), gives 80 titles. However, for the purpose of this project, only reports relevant to granular resources were considered. The reports with online draft version were also flagged in the list. This preliminary list was faxed to DIAND departmental representatives on March 07, 2005, for review.

The comments from DIAND departmental representatives were received on March 11, 2005. The list was updated in light of those comments, by indicating which EBA reports have been indexed in NGRB or ASTIS. The ASTIS record numbers and libraries having copies of the reports were also indicated in the list.

4.0 RESULTS

The results of this review are summarized in Table 1. This table describes a brief description of the projects (type of work, location), EBA's project number, sponsoring agency, ASTIS record numbers and the libraries having copies of these reports, and online availability of the report in PDF. It should be noted that reports of the projects listed in Table 1 are in different EBA's offices, and availability of some of these reports still needs to be confirmed. Also, in some cases, fieldwork may be completed but reports have yet to be finalized.


